Are you an organised person, Croatian speaking, who would like to make a difference to your community? Would you like to contribute to assisting in older members of our community to remain in their homes and nurture their independence and quality of life?

Would you like provide high quality care management services through the delivery of Home Care Packages (Levels 1 – 4) in Geelong and western region of Melbourne?

About the role

The primary focus of this role is to provide culturally appropriate care management and services to Home Care Package consumers through a care management approach underpinned by holistic assessment of clients' needs. The role involves assessment of consumers living in their own home to determine the level of care management support and services required under a Consumer Directed Care packages. The Care Manager is responsible to identify, assess clients, plan, implement, monitor and review client budget, services and needs with the aim of supporting them to remain living in the community setting following the principle of CDC.

We seeking one individual (FTE) for our Geelong Region. The position is a one year contract and reviewed at the end of the one year term. The position will be remunerated at the SCHADS Award, Schedule B, Level 5 (Pay point determined on experience). Salary packaging benefits.

Duties and responsibilities

- Assessment of consumer needs and support in regards to Consumer Directed Care packages guidelines
- Determine consumer strengths and needs and assess eligibility for services within the provisions of the relevant legislation, policy directions and program guidelines
- Identify and review consumer care plan goals , organize and manage packages of support to enable them to safely remain at home and in the community
- Liaise with internal and external providers and make referrals to appropriate services to meet consumer goals within service levels
- Provide direct Care Management services that include home visits and telephonic communication with consumers, family and service providers
- Effectively manage consumers budgets
- Work in a team-based environment, supporting colleagues when and where required
- Adhere to other administration duties, as requested
- Adhere to ACCS policies, procedures and quality standards

What we are looking for

- Tertiary qualifications relevant to Social Work, Nursing, Care Management or a similar discipline
- Skills and experience in providing assessment and Care management to high need and complex consumers
- Ability to liaise and consult with medical, allied health and other community professionals at all levels
- Ability to develop positive relationships with consumers, service providers and the community
- Ability to work with and assist other staff to effectively support consumers according to their individual needs and personal preferences
- Knowledge of the aged care sector, resources and the medical issues facing the aged
- Knowledge and understanding of the principles of a CDC package
- A demonstrated knowledge of best practice and quality standards in Care management
- Ability to speak Croatian language

Jeste li organizirana osoba, koja govori hrvatski jezik i koja može na kvalitetan način voditi brigu o skrbi za korisnike usluga paketa za kućnu njegu (paket na stupnjevima 1 - 4), na području Melbourne-a?

O radnom mjestu

Primarni zadatak ove pozicije je osigurati odgovarajuće i kulurološki primjerene usluge skrbi korisnicima usluga paketa kućne skrbi, koristeći holistički pristup. To uključuje procjenu potreba korisnika koji žive u vlastitom domu kako bi se odredila razina potpore i usluga, prema modelu izbora “Consumer Directed Care”. Voditeljica programa skrbi putem paketa (Care Manager) je odgovorna za identifikaciju, procjenu potreba korisnika, planiranje, provođenje, praćenje i pregled proračuna, usluga i potreba klijenata s ciljem da ih podrži u nastojanjima da ostanu živjeti u svojoj kući i u zajednici.

Ovo je pozicija sa punim radnim vremenom, ili smanjenim radnim vremenom (25 sati tjedno) za Geelong i zapadni dio Melbourne-a. Pozicija će biti plaćena prema Pravilniku SCHADS, kategorija B (stupanj određen iskustvom). Povlastice uključuju “salary packaging”.

Dužnosti i odgovornosti

- Procjena potreba korisnika i potpora u smislu smjernica modela skrbi “Consumer Directed Care”
- Utvrditi koji su pozitivni čimbenici a isto tako i potrebe korisnika usluga, i ocijeniti prihvatljivost za usluge u skladu s relevantnim zakonima, pravilima i programskim smjernicama
- Prepoznati i razmatrati ciljeve plana skrbi korisnika usluga, organizirati i upravljavati paketima kako bi korisnici mogli ostati sigurni u kući i zajednici
- Povezivati se s internim i vanjskim pružateljima usluga i uputiti korisnike na odgovarajuće usluge kako bi se ispunili ciljevi unutar odobrene razine usluge
- Osigurati izravne usluge vođenja programa, a koji uključuju kućne posjete i telefonsku komunikaciju s korisnicima usluga, njihovim obiteljima i drugim pružateljima usluga
- Učinkovito upravljati proračunom korisnika usluga
- Raditi u timskom okruženju u organizaciji, podupirati radne kolege i pomoći tamo gdje je to potrebno
- Ispunjavati ostale administrativne zadatke, ukoliko je potrebno
- Pridržavati se ACCS pravilnika, utvrđenih postupaka i standarda kvalitete

- Kvalifikacije relevantne za socijalni rad, skrb, “Care management” ili slične discipline
